Change is in many ways a healthy part of organizational growth. In the year that ended June 30, 2021 we continued to experience disruption, change, and the transformation of our program with the current Department of Education Earlylearn contract ending and a new Department of Education Birth to Five contract on the horizon. We continued to experience the effects of the pandemic on all of our families and staff as the fight to overcome this virus engages us all. We continued to move forward with hope and determination to provide our service and support to Bloomingdale Families.

The beginning of the program year was one of fear and uncertainty as we reopened our doors to onsite learning a little later than usual at the end of September 2020. With so many unknowns, many of our families chose to continue the virtual experience.

We provided a blended service model experience, serving some children onsite and others remotely. Our Homework Help program also continued but remained fully remote through this year as well.

As this was the final year of our Earlylearn contract we began to prepare for what the future would provide for us. By June 30 we consolidated our three locations into one and will begin the new contract year in one location as a 3-k and pre-k site and made programmatic and operational adjustments accordingly.

We look forward to the new contract, and to the possibilities of a healthy future which will allow us the opportunity to renew and rebuild the Bloomingdale Family Program.
